4. FIRST AID MEASURES

4.1 Description of first aid measures

Eye If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

Inhalation If inhaled, remove from contaminated area. Apply artificial respiration if not breathing.

Skin If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by a Poisons Information Centre or a doctor.

Additional information STYRENE-BUTADIENE COPOLYMERS: Over exposure to styrene monomer may result in styrene sickness. Styrene monomer is classified as possibly carcinogenic to humans (IARC Group 2B). 1,3-Butadiene is classified as carcinogenic to humans (IARC Group 1). However when both chemicals are bound together in a polymeric form the copolymers are not classifiable as to their carcinogenicity in humans (IARC Group 3).
